### **1) Validity of this privacy policy**

This privacy policy applies to the use of the website <https://elearning-childprotection.se> and the entry in the list of interested parties for course participation in the above-mentioned online course on this website.

### **2) Responsibility**

The responsible provider of the website is the Clinic for Child and Adolescent Psychiatry/Psychotherapy at Ulm University Hospital (Director: Prof. Dr. Jörg M. Fegert). The University Hospital of Ulm is responsible for data processing. ### **3) Your data protection rights**

GDPR = EU General Data Protection Regulation

Within the framework of the applicable legal provisions, you have the right to free information about the personal data processed about you at any time (Art. 15 GDPR) and, if applicable, a right to correct incorrect data (Art. 16 GDPR), delete your data (Art. 17 GDPR), the right to restrict processing (Art. 18 GDPR), to object (Art. 21 GDPR) and the right to data portability of data provided by you (Art. 20 GDPR). With regard to the right to information and the right to delete data, restrictions or special requirements may apply in accordance with the GDPR and the Baden-Württemberg State Data Protection Act.

### **4) General information on the processing of personal data**

We process your personal data in compliance with the EU General Data Protection Regulation (GDPR) and its national implementing laws. The data will only be processed and evaluated within the project. Under no circumstances will we pass on your data with a direct personal reference to third parties.

The legal basis for the processing of your personal data when visiting this website is Art.6 para.1 lit f DSGVO.

## **5) Data collection and storage**

The website operator, SoonSystems GmbH, stores the following data in the server log files:

- Referrer URL
- IP address
- Date and time of the server request

The collection of this data is not used to analyze the flow of visitors or for further processing, but it is needed to detect attacks on the server, for example. The log files are deleted automatically after 49 days.

In the footer of the website <https://elearning-childprotection.se> you will find the link to a contact form. The mail address and the corresponding mailbox are provided by the provider Hetzner (<https://www.hetzner.com>). The transmission of the mails from the contact form to the server is encrypted. All received mails will be deleted 6 months after the end of the project (project end 28.02.2025, deletion 31.08.2025). ## **6) Deletion of your personal data**

Stored personal data will be deleted if you revoke your consent to processing, if knowledge of the data is no longer required to fulfill the purpose for which it was stored, or if processing is inadmissible for other legal reasons. Data for billing and accounting purposes are not affected by a request for deletion.

If you wish to delete your entry in the list of interested parties, you will find a link for this in the confirmation mail you receive after the entry. If you can't find the mail anymore, you can contact the project team via the contact form on the website and ask for deletion. The project team will then delete your entry.

The entries in the interested parties list serve us to collect persons interested in participating in the project and to be able to write to them by mail as soon as the possibility of registering for course participation exists. The data entered in the list of interested parties will be deleted 56 days after the mail is sent announcing the possibility of entering the course registration.

## **7) Security measures**

We have taken extensive precautions to protect the security of your data. In the area of the website where personal data is processed, we use the industry standard SSL (Secure Sockets Layer) to encrypt this data for data transmission to the server. Our IT systems are protected against data loss and data misuse in accordance with the current state of the art.

In order to access the area of the website where the data can be retrieved, individual access data are required, which are only issued to employees of the Clinic for Child and Adolescent Psychiatry/Psychotherapy Ulm who are involved with the project. Employees of the project sponsor (Lower Saxony Ministry of Education and Cultural Affairs) do not have access to the personal data collected in the project. They only receive anonymized aggregated data from the project team.

## **8) Facebook**

Our website contains references (links) to the external social network Facebook. This website is operated exclusively by Facebook Inc., 1601 S. California Ave, Palo Alto, CA 94304, USA (Facebook). The links are identified within the framework of our Internet presence by the Facebook logo or the addition "Like". No Facebook plugins are used.

When you visit our website, functions and data transfers to Facebook are not automatically active. The Facebook plugins are only activated when you click on the links, and your browser establishes a direct connection with Facebook servers. If you follow the links and are logged in to Facebook with your user account there at the same time, the information that you have visited our website will be forwarded to Facebook. Facebook can assign your visit to the website to your account. This information is transmitted to Facebook and stored there. To prevent this, you must log out of your Facebook account before clicking on the link.
